**CERTIFICATE OF AMENDMENT
TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS
FOR SUNSET HILLS P.U.D.**

This Amendment to the Declaration of Covenants, Conditions and Restrictions for Sunset Hills P.U.D. ("Declaration") is executed on the date set forth below by the Granite Homeowners' Association ("Association").

RECITALS

A. Real property in Salt Lake County, Utah, known as the Sunset Hills P.U.D., was subjected to covenants, conditions, and restrictions pursuant to the Declaration recorded May 29, 2009, in the Salt Lake County Recorder's Office as Entry No. 10715287;

B. This amendment shall be binding against the property described in EXHIBIT A and the Declaration and any annexation or supplement thereto;

C. This amendment is intended to create a reinvestment fee covenant.

D. All capitalized terms in this amendment shall have the same meaning as given to them in the Declaration;

E. The President, Vice President, and Secretary certify that this amendment was approved by Owners casting seventy-five percent of the votes at the election voted affirmatively for the adoption of this amendment as required by Declaration Article XI, Section 9.2;

NOW, THEREFORE, the Association hereby amends the Declaration as follows:


Declaration Article V, Section 5.2 shall be amended in its entirety to read as follows:

5.2 Assessment of Certain Costs. In the event that the need for maintenance or repair of Common Areas or any other areas maintained by an Association is caused through the willful or negligent act of any Owner (except Declarant), his or her family, guests or invitees, the cost of such maintenance or repairs shall be added to and become part of the Maintenance Charge to which such Owner's Lot is subject and shall be secured by the Assessment Lien. Additionally, every Lot at the time the Lot is transferred shall be subject to a reinvestment fee not to exceed ½% of the sale price of the Lot (the exact amount to be determined by the Board) for the purpose of covering Association expenses, including without limitation: administrative expenses; purchase, ownership, leasing, construction, operation, use, administration, maintenance, improvement, repair, or replacement of association facilities, including expenses for taxes,


insurance, operating reserves, capital reserves, and emergency funds; common planning facilities, and infrastructure expenses; obligations arising from an environmental covenant; community programming; open space; recreation amenities; or charitable expenses. Reinvestment fees shall be considered Maintenance Charges to which a Lot is subject and shall be secured by the Assessment Lien.

IN WITNESS WHEREOF, the Association, by and through its President, Vice President, and Secretary have executed this Amendment to the Declaration as of the 11 day of December, 2013.

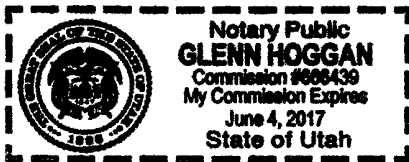


