NOTICE OF CERTIFICATION AND LIEN

Pursuant to the authority of §17B-1-902, Utah Code Annotated, 2008 (the "Statute"), notice is hereby given that Snyderville Basin Water Reclamation District (the "District"), has certified to the Treasurer of Summit County, Utah, that as of this date there are past due fees and charges for wastewater service provided by the District to the following properties in the attached Lien List Exhibit A.

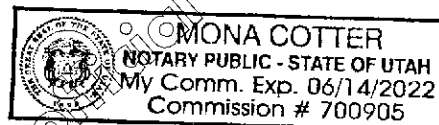
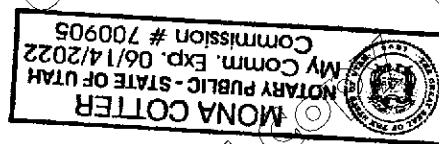
