Parcel 1: Part of the Northeast Quarter of Section 2, Township 5 North, Range 2 West, Salt Lake Base and Meridian, U.S. Survey: Beginning at the intersection between the North Section line and the Westerly right of way line of D. & G. W. R. R. said point also being approximately 96 feet West of the Northeast Corner of said Section 2, and running thence Southwesterly along said Westerly right of way line of D. & G. W. R. R. to a point 660 feet West from the East line of said Northeast Quarter, thence North parallel to and 660 feet West from the East line of said Northeast Quarter to the South line of Midland Drive, thence Northeasterly along said South line to a point West from the point of beginning, thence East to the point of beginning. Containing 5.10 acres more or less.

Parcel 2: Part of the North half of the Northeast Quarter of Section 2, Township 5 North, Range 2 West, Salt Lake Meridian, U.S. Survey: Beginning on the South line of Midland Drive, 660 feet West and 70 feet South of the Northeast Corner of said Quarter Section, thence Southwesterly along Hooper Road to South line of North half of said Quarter Section, thence East to the Westerly right of way line of D. & G.
