2. The vacated street of 2700 South mentioned in Ordinance 93-8, a copy of which is attached hereto and recorded herewith, is legally described as follows:

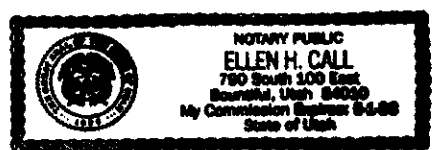
Beginning on the west line of a 50-foot street (625 West) at a point which is S 89 °57' E 150.68 feet along the centerline of a 66-foot street (2600 South) and S 0 °05'30" E 364.83 feet along the west line of said 50-foot street (625 West) from a Davis County survey monument at the intersection of State Highway 91 and 2600 South Street, and running thence N 89 °57' W 314.68 ft. to the easterly line of said highway; Thence S 31 °19'30" W 58.50 ft. along the easterly line of said highway; Thence S 89 °57' E 345.01 ft. to the west line of said 50-foot right-of-way; Thence N 0 °05'30" W 50.00 ft. to the point of beginning. Located in the Southeast quarter of Section 36, Township 2 North, Range 1 West, SLB&M, Davis County, Utah.

ORDINANCE 93-8

AN ORDINANCE VACATING 2700 SOUTH BETWEEN 625 WEST AND HIGHWAY 89

BE IT ORDAINED BY THE CITY COUNCIL OF BOUNTIFUL, UTAH:

Section 1. Pursuant to Section 10-8-8 et.seq., Utah Code Annotated, 1953, as amended, the governing body is of the opinion that there is good cause for vacating a portion of a public street as hereafter described and that such vacation will not be detrimental to the general interest of the city.

Section 2. A public street known as 2700 South, located between the west line of 625 West and the east line of Highway 89, is hereby vacated.

Section 3 -- Effective Date. This ordinance shall take effect immediately upon first publication.

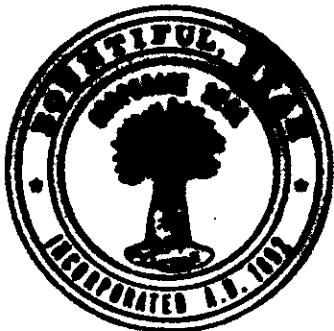
