SUPPLEMENTAL DECLARATION AND DESIGNTION BY OWNER

THIS SUPPLEMENTAL DECLARATION AND DESIGNATION BY OWNER
("Supplemental Declaration"), dated July 15, 2014 ("Effective Date"), is entered into by the
Redevelopment Agency of Salt Lake City, a public agency ("Declarant"); the Salt Lake City

In accordance with Section 1.48 of the Declaration, pursuant to the Master Lease Agreement, dated as of June 1, 2013, between the Authority, as lessor, and the City, as lessee, as amended by the First Amendment to Master Lease Agreement, dated March 1, 2014, between the Authority, as lessor, and the City, as lessee, the City is the Owner (as that term is defined in the Declaration) of the City Lot. The Declarant Lots and the City Lot constitute all of the lots within the Marmalade Block Development and all of the lots that are subject to the Declaration.
- C. Declarant, the City, and the Library Board are executing and delivering this Supplemental Declaration for the purpose of designating the Land Use Classification for the City Lot.
- D. The City and the Library Board are also executing and delivering this Supplemental Declaration for the purpose of designating the Library Board to act as the Owner of the City Lot, subject to this Declaration.

Pursuant to Section 1.48 of the Declaration, the City designates the Library Board to act as the Owner of the City Lot, subject, however, to the rights and remedies granted to U.S. Bank National Association, as trustee, under the Indenture of Trust, Mortgage, Assignment of Lease Agreements and Security Agreement, dated June 1, 2013, and recorded in the Salt Lake County Recorder on June 20, 2013, 2014, as Entry No. 11667560, in Book 10151 beginning at Page 3522, as amended by the First Supplemental Indenture of Trust to Indenture of Trust, Mortgage, Assignment of Lease Agreements and Security Agreements, dated March 1, 2014, and recorded in the Salt Lake County Recorder on March 20, 2014, as Entry No. 11821140, in Book 10218, beginning at Page 3282.
