AMENDMENT #3

TO

AMENDED AND RESTATED DECLARATIONOF COVENANTS, CONDITIONS AND RESTRICTIONS FOR MONTE CRISTO CONDOMINIUM

This Amendment #3 to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Monte Cristo Condominium is made and executed by the Monte Cristo Homeowners Association, of 6332 S. Seville Road, Salt Lake City, UT 84121 (the "Association").

RECITALS

- A. The Amended and Restated Declaration of Covenants, Conditions and Restrictions for Monte Cristo Condominium was recorded in the office of the County Recorder of Salt Lake County, Utah on March 6, 1997 as Entry No. 6587122 of the official records (the "Declaration").
- B. The Association is the managing agent of the owners of the real property located in Salt Lake County, Utah, described with particularity on Exhibit "A," attached hereto and incorporated herein by this reference (the "Property").
 - C. The Property is subject to the Declaration.
- D. The Association desires to amend the Declaration to satisfy the requirements of FHA for certification.
 - E. All of the voting requirements to amend the Declaration have been satisfied.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Property and the owners thereof, the Association hereby executes this Amendment #3 to the Declaration.

- 1. Section 10 of Article XXII of the Declaration, as amended is hereby deleted in its entirety and the following language is substituted in lieu thereof:
 - 10. <u>Fines, Penalties and Sanctions</u>. For violations of the rental restrictions the Association may:
 - ♦ Suspend voting rights.

- Suspend privilege to use of recreation facilities.
- ♦ Assess fines.
- ♦ Immobilize, tow or impound motor vehicles.
- ♦ Call animal control and remove pets
- ♦ Obtain injunctive Relief
- ♦ Recover Damages
- ♦ Recover attorneys fees and costs

Unless otherwise determined by the Management Committee fines for violations of the rules and regulations shall be administered as follows:

♦	First Offence	Warning
♦	Second Offence	\$100.00
♦	Third Offence	\$200.00
•	Fourth and Additional Offences	\$300.00

No fine for a single offence may exceed the statutory limit.

- 2. In the event of any conflict, incongruity or inconsistency between the provisions of the Declaration, as amended and supplemented, and this Amendment #3, the latter shall in all respects govern and control.
- 3. The effective date of this Amendment #3 is the date it is recorded in the office of the County Recorder of Salt Lake County, Utah.
