In this action, Tailor Built Homes, LLC, having been regularly served with process and having failed to appear and answer Plaintiff's Complaint filed herein, the time allowed by law for answering having expired, the default of Tailor Built Homes, LLC having been duly entered according to law, now upon application of the Plaintiff to the above-entitled Court, Judgment is hereby entered against Tailor Built Homes, LLC pursuant to the Prayer for Relief in Plaintiff's Complaint.

WHEREFORE, by virtue of the law, and by reason of the premises aforesaid, it is hereby ORDERED, ADJUDGED AND DECREED that Plaintiff Lighting Design, LLC is awarded Judgment against Tailor Built Homes, LLC in the amount of \$80,747.80 as follows:

c.	Costs through 12/10/18:	\$ 412.52
d.	Attorneys' fees through 12/10/18 (UCA 58-55-603(2) and the Credit Application):	\$ <u>2,353.75</u>
	TOTAL	\$80,747.80

For post-judgment interest to accrue on the amount of \$80,747.80 at the rate of 12% per annum Utah Code Ann. Section 58-55-603(2).

Pursuant to Rule 54(b) of the Utah Rules of Civil Procedure, this judgment is certified as a final judgment against Defendant Tailor Built Homes, LLC.



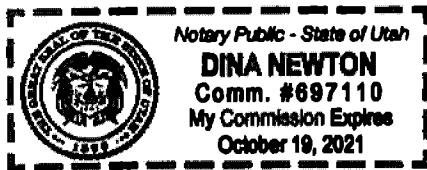


