# FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR GALENA PARK TOWNHOMES

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR GALENA PARK TOWNHOMES ("Amendment") is entered into to be effective as of 12, 2015, by D.R. HORTON, INC., a Delaware corporation (the "Declarant").

## **RECITALS**

- A. The Declaration of Covenants, Conditions and Restrictions for Galena Park Townhomes was recorded on September 19, 2014 as Entry No. 11916385 in Book 10261 beginning at Page 5588 in the official records of Salt Lake County (the "<u>Declaration</u>").
- B. This Amendment affects the Property, which is located in Salt Lake County, Utah and described on the attached Exhibit A, which is incorporated herein by this reference.
- C. This Amendment is made by Declarant pursuant to Section 3.32(c) of the Declaration.
- D. This Amendment is intended to clarify the obligations of the Owners with respect to pets.

# **AMENDMENT**

NOW, THEREFORE, in consideration of the foregoing recitals, Declarant hereby executes this Amendment for and on behalf of, and for the benefit of, all Owners and the Members:

- 1. <u>Recitals</u>. The Recitals set forth above and the Exhibits attached to this Amendment are each incorporated into the body of this Amendment as if set forth in full herein.
- 2. <u>Amendment to the Declaration</u>. This Amendment constitutes an amendment to the Declaration. In the event of any conflict or inconsistency between the terms of this Amendment and the terms of the Declaration, the terms of this Amendment shall control.
- 3. Pets. The last sentence of Section 3.5(f)(20) of the Declaration is hereby deleted in its entirety and replaced with the following:

4839-6120-7575.5

"Within the Limited Common Area of any Lot, if the Owner desires: (a) to keep a pet outside overnight or (b) to keep a pet unleashed outside at any time, then in order to do so the Owner of such Lot must first erect a fence enclosing the Limited Common Area for such Lot, and the Owner of such Lot must receive prior written consent from the Board of Directors for the type, material and color of such fence before installing such fence."

- 4. <u>Capitalized Terms</u>. Any capitalized term not defined herein shall have the same meaning as set forth in the Declaration.
- 5. <u>Amendment</u>. Except as amended in this Amendment, all of the terms, conditions, agreements and provisions set forth in the Declaration shall be and they hereby are reaffirmed, ratified, confirmed and approved in their entirety and shall remain in full force and effect.
