
### WARRANTY DEED

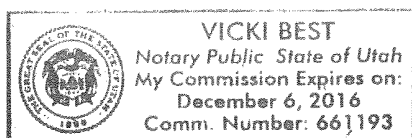


