AMENDMENT OF DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SUNRISE MEADOWS

THIS AMENDMENT OF DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS (this "Amendment") is made and executed effective as of July 22. 2003 by Sunrise Meadows, L.L.C., a Utah Limited Liability Company, with a mailing address of 982 North Buffalo Dr., Saratoga Springs, Utah 84043 ("Declarant").

RECITALS:

- A. Declarant as the owner of the property located in the City of Saratoga Springs, Utah County, Utah, executed as "Declarant: and recorded that certain Declaration of Covenants, conditions and Restrictions For Sunrise Meadows, Plat A, dated November 2001 and recorded May 10, 2002 as Entry No. 0542163: 2002 in the Utah County Recorder's Office (the "CC&R's")
 - B. The Amendments section of the CC&R's provides that Declarant reserved the right to annex additional land into the Association and the CC&R's without the consent of members until all lots are sold.
 - C. Declarant has previously filed CC&R's for Plat B, dated NWCMVCR 7,2001 and recorded May 10,2002 as Entry No. 054264:2002 in the Utah County Recorder's Office as well as for Plat C, dated NOVCMVCR 7,2001 and recorded May 10,2002 as Entry No. 054265:2002 in the Utah County Recorder's Office. Those filings were of identical CC&R's to Plat A recorded above, except for the plat designation. This Amendment is intended to eliminate any potential ambiguity over the homeowner's association and assure all interested parties that only a single homeowner's association is to be organized for the entire subdivision, regardless of the number of individual plats recorded.
 - D. This Amendment is being executed and recorded to annex the land covered by Sunrise Meadows, Plats K&L into the CC&R's and the Association and Amends the CC&R's to include the Property covered by Plats K&L in addition to the property already covered by the CC&R's. Furthermore, Declarant subjects Plats K&L to the CC&R's as amended.
