





Commencing at the East quarter corner of Section 36, Township 3 South, Range 1 West, Salt Lake Meridian;

thence South 89°47'29" West 1420.40 feet along quarter section line;

thence North 00°12'31" West 369.63 feet to a point on the northerly right of way line of Golden Harvest Road and the POINT OF BEGINNING;

thence North 89°57'28" West 47.77 feet along said right of way to a point on the Easterly boundary of Lot A, Greenfield Farms Phase IV Subdivision, according to the official plat thereof, as recorded in the office of the Salt Lake County Recorder;

thence North 00°02'32" East 432.10 feet along said boundary extended;

thence North 89°49'24" East 137.15 feet;

thence South 14°58'45" West 421.72 feet to a curve to the left having a radius of 20.00 feet, a central angle of 104°56'16" and a chord that bears South 37°29'23" East 31.72 feet;

thence along said curve a distance of 36.63 feet to the POINT OF BEGINNING.
