RIGHT OF WAY DEED

Right of way for highway known as N. R. S. Project No. 132-B across the grantor's land in the SE 1/4 of SW 1/4 of Section 11, T. 6 N. R. 2 E. S. L. B. & M. Said right of way is a part of a strip of land 80 feet wide, 40 feet on the northwest side of the center line of survey of said project. Said right of way is more particularly described as follows: From the South 1/4 corner of said Section 11, T. 6 N.
