(A) **“Security Instrument”** means this document, which is dated July 20, 2015, together with all Riders to this document.

(B) **“Borrower”** is GARY A. CLARK AND PAMELA S. CLARK, HUSBAND AND WIFE. Borrower is the trustor under this Security Instrument.



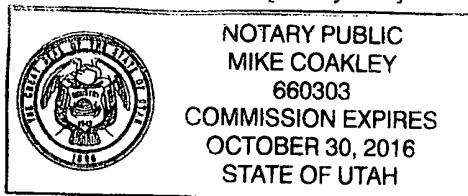
