

AFFIDAVIT

James H. Wood and Alice P. Wood husband and wife being first duly sworn on Oath depose and say:

That they have been married continuously since October 11, 1928 and have resided together since that date. They further state that they have never been divorced or a suit for divorce has never been entered against either of the signers of this affidavit.

James H. Wood further states that he never was or never has been married to Mildred M. Wood and further that he was not the defendant in an action for divorce entered in 1938 by Mildred M. Wood against James H. Wood but that the defendant in that suit was James Henry Wood while the name of the affiant is James Harvey Wood.

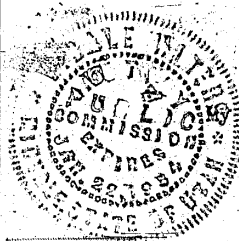
