**AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND
RESTRICTIONS AND RESERVATIONS FOR
EAST TOWN VILLAGE CONDOMINIUM**

**This Amendment to the Declaration is executed on the date set forth below by
East Town Village, L.C. (“Successor Declarant”).**

RECITALS

A. Real property in Salt Lake County, Utah, known as East Town Village Town Condominium, an Expandable Utah Condominium Project was subjected to covenants, conditions, and restrictions pursuant to a Declaration recorded March 5, 2007 in the Salt Lake County Recorder’s Office as Entry No. 10023015;

B. The Declaration was amended and restated in its entirety on June 9, 2011 as Entry No. 11195609 in the Salt Lake County Recorder’s Office;

C. The Declaration was amended again on November 17, 2014 as Entry. No. 11946505 in the Salt Lake County Recorder’s Office to, in part, define Additional Land;

C. The purpose of this Amendment is to remove Lots 4, 5, and 6 described herein as Exhibit C from the Additional Land;

D. This amendment shall be binding against the property described in EXHIBIT A and the Declaration and any annexation or supplement thereto;

E. All capitalized terms in this amendment shall have the same meaning as given to them in the Declaration;

F. The Successor Declarant certifies that the Period of Successor Declarant’s Control has not expired. Consequently, under Declaration Article III, Section 32(d), Successor Declarant has the unilateral right to amend the Declaration;

G. The Successor Declarant certifies that there are currently no Eligible Mortgagees, as that term is defined in the Declaration.

NOW, THEREFORE, the Successor Declarant hereby amends the Declaration as follows:

Declaration Exhibit "B" is amended in its entirety to read the same as Exhibit "B" to this amendment.

An Exhibit "D" to the Declaration is hereby added to read the same as Exhibit "C" to this amendment

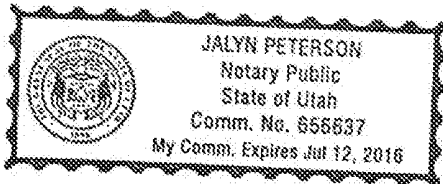
