Jones and Mary Ann Jones, his wife of Davis County, Utah, grantors for the sum of Ten (10) Dollars, paid to grantors by The Telluride Power Company, a Colorado corporation, hereby grant to said company, its successors and assigns, the right to erect and maintain Two (2) lines of poles and electric transmission circuits across the following described tract of land in Davis County, Utah, to-wit:
