Thelma S. Slaugh, after being first duly sworn, deposes and says as follows:

- 1. On September 4, 1987, Duane E. Slaugh as Grantor and as Trustee, executed a Declaration of Trust on September 4, 1987, creating the Duane E. Slaugh Trust; and also on September 4, 1987, Thelma S. Slaugh as Grantor and as Trustee executed a Declaration of Trust creating Thelma S. Slaugh Trust.
- 2. On August 1, 2000, Duane E. Slaugh and Thelma S. Slaugh executed a joint First Amendment to Declaration of Trust ("Trust Agreement") consolidating the Duane E. Slaugh and Thelma S. Slaugh Trust into one Trust referred to as the Duane and Thelma Slaugh Trust ("Trust"). A copy of the Trust Agreement and prior documents thereto may be obtained from the undersigned or from Thomas Christensen, Jr. at 4766 S. Holladay Blvd. Holladay, Utah 84117.
 - 3. Article II of the Trust Agreement provides in applicable part as follows:

SUCCESSOR TRUSTEE

"DUANE E. SLAUGH and THELMA S. SLAUGH are appointed as the present Co-Trustees. Said Co-Trustees shall continue to as Co-Trustees under the

Trust until their death, resignation, disqualification or incompetency. If one of the Co-Trustees dies, resigns or become incompetent, the other Co-Trustee may serve alone".

- 4. Duane E. Slaugh, died on May 15, 2016. A certified copy of his death certificate is attached hereto. Duane E. Slaugh, who, as Trustee, appears as the title holder of the below described real properties is one and the same as Emery Duane Slaugh, who is designated as the decedent on the attached death certificate.
- 5. Thelma S. Slaugh hereby accepts the appointment as successor Trustee of the Trust and hereby certifies that the Trust is in full force and effect.
- 6. The assets of the Trust include the following described real property and trust deed beneficial interests situated in Salt Lake County, State of Utah:
