**MEMORANDUM OF
Utility Permit Agreement**


NOTICE IS HEREBY GIVEN of that certain Utility Permit Agreement (the "Permit") made and entered into as of July 5, 2016 between Salt Lake City Corporation, 1530 South West Temple, Salt Lake City, Utah, (the "City"), and Questar Gas Company, 1140 West 200 South, PO Box 45360, Salt Lake City, Utah 84145-0360 ("Permittee"), a copy of which is on file and available for inspection at the Salt Lake City Recorder's office.

For the consideration set out in the Permit, the City has entered into an agreement to allow use of City owned property for installation of an 8" natural gas line within a 12" casing under its Jordan and Salt Lake City Canal at approximately 10865 South State Street located within Salt Lake County, Utah, parcel number 28-18-354-077 described below:

Beginning at a point on the Westerly Line of the Jordan and Salt Lake Canal, said point being South 89°32'58" East 188.98 feet and South 89°31'28" East 125.10 feet and South 00°03'20" East 10.00 feet and South 89°31'25" East 37.80 feet and North 16°51'31" East 10.42 feet and South 89°31'25" East 30.99 feet and South 16°51'31" West 490.95 feet and North 89°35'40" West 54.07 feet and North 00°03'20" West 48.60 feet and South 16°51'31" West 18.03 feet from the Northwest Corner of Lot 4, Section 18, Township 3 South, Range 1 East, Salt Lake Base and Meridian, said point also being South 00°00'20" East 1763.03 feet along the Section Line and perpendicularly North 89°59'40" East 184.12 feet from the West Quarter Corner of said Section 18, Thence South 00°07'29" West 166.32 feet to a point on the Easterly Line of said Jordan and Salt Lake Canal the Point of Terminus.


