## ELECTRICAL BOX EASEMENT

Jaime Steren and Elaine Steren, the Undersigned, GRANTOR, (and each and all of them if more than one) for good and valuable consideration, do hereby grant and convey to Schuyler Buckley, GRANTEE, its successors, assigns, lessees, licensees and agents, a perpetual Right of Way for ingress and egress, Electrical Box Easement to construct, reconstruct, operate, maintain and remove such Electrical Box facilities as Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, in Salt Lake County, Utah, to wit:

Beginning at the Southwest Corner of Lot 2, Block 93, Plat "C", Salt Lake City Survey, said point being the Southeast Corner of Lot 1, Rose Park Plat "A" Subdivision as recorded with the office of the Salt Lake County Recorder in Book J of Plats, at Page 141, and running thence North 00°00'35" West along the East line of said Lot 1, 165.04 feet (North 165.00 feet record), said point being the Southwest Corner of Lot 14 of said Rose Park Plat "A" Subdivision, thence North 89°59'05" East 50.00 feet along the South line of said Lot 14, Rose Park Plat "A" Subdivision; thence South 00°00'35" East 55.07 feet to the Point of Beginning; running thence South 89°59'05" West 10.00 feet; thence South 00°00'35" East 5.00 feet; thence North 89°59'05" East 10.00 feet; thence North 00°00'35" West 5.00 feet to the Point of Beginning.


