DEED

JOHN M. WALLACE and GLENN WALKER WALLACE, his wife, HAROLD H. BENNETT and EMILY BENNETT, his wife, L. B. SWANER and JUNE S. SWANER, his wife, and L. S. SWANER, a single person, residents of Salt Lake County, State of Utah, Grantors, hereby convey and warrant to SALT LAKE CITY, a municipal corporation of the State of Utah, Grantee, for the sum of One and no/100 Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged,

A perpetual easement over and across a parcel of land for the purpose of operating and maintaining thereon certain existing sanitary sewer lines, said easement being 16 feet wide, the same projecting eight (8) feet on each side of, and extending eight (3) feet beyond the limits of each of the center lines hereinafter described, EXCEPT as hereinafter provided.

Where any building or structure whatsoever, is situated such that the vertical projection of such building or structure is contained within the boundaries of the easement described herein, said boundaries shall terminate at the limits of and outside of said projection; HOWEVER, the grantee shall have the right of reasonable and perpetual access for the purpose of necessary maintenance, repair and replacement to any sewer line, the center line of which is described herein, and which projects thru, over or under said building or structure.

Where courses of and distances along the center lines herein described are herein referred to manholes, it shall be expressly understood that said bearings and distances shall extend to the vertical axis of said manholes.

Said centerlines are nereinafter described as follows:

Deginning at a point in the vertical axis and centerline of Manhole A9-2A, said point being 560.81 feet S. 89° 56' 52" W., and 542.68 feet S. 0° 05' 38" W., from the intersection of the centerline of 17th South Street and the Salt Lake City Survey monument line on Redwood Road; thence bearing N. 0° 05' 38" W.,155.78 feet to Manhole A9-2; thence N. 62° 21' 08"W., 414.2 feet to the southerly face of Pump House 18-A; thence continuing N. 62° 21' 08" W. 279.6 feet, thru and beyond said pump house to Manhole A9-1; thence N. 72° 54' 38" W., 405.67 feet to Manhole A9; thence S.0° 05' 15" 1., 120.65 feet to Manhole A-10; thence N. 88° 22' 15" W., 124.0 feet along a branch line to Manhole A-10; thence N. 88° 22' 15" W., 124.0 feet along a branch line to Manhole A-10-1. Also, from said Manhole A-10, bearing S. 0° 05' 15" E., 150.04 feet to Manhole A-12; thence N. 89° 52' 45" E., 131.02 feet to Manhole A-12-1. Also, from said Manhole A-12, bearing S. 57° 49' 45" W., 175.42 feet to Manhole A-12-1A. Also, from said Manhole A-13, bearing S. 0° 05' 15" E., 149.63 feet to Manhole A-13; thence S. 89° 49' 45" E., 130.33 feet to Manhole A-12-1. Also from said Manhole A-13, bearing S. 0° 05' 15" E., 369.39 feet to Manhole A-14, the vertical axis and center of which is located approximately 345.8 feet north and 39.0 feet east of the intersection of the centerlines of Layton Ave. and Industrial Road; thence N. 73° 50' 45" E., 136.6 feet to Manhole A-14-3; Also from said Manhole A-14, running S. 75° 02' 15" E., 193.0 feet to Manhole A-14-1: Also

from said Manhole A-14 running S. 45° 14' 35" W., 15.0 feet; thence
N. 89° 57' 15" W., 185.86 feet to Manhole A-14-1A: Also, from said Manhole
A-14, running S. 43° 21' 15" W., 343.10 feet to a point hereinafter referred
to as Point "A"; also contimuing S. 43° 21' 15" W., 50.0 feet to an intersection with the south face of Pumphouse 185, which intersection shall be
hereinafter referred to as Point "5" (NOTE:) From said Point "A" to said
Point "B" said easement shall extend an additional 10 feet in width on the
northeasterly side of the last said course.
