# FIRST AMENDMENT TO THE BYLAWS OF ROWHAUS CONDOMINIUMS HOMEOWNERS' ASSOCIATION, INC.

This First Amendment to the Bylaws of Rowhaus Condominiums Homeowners' Association, Inc. ("Amendment") is executed on the date set forth below, by the Rowhaus Condominiums Homeowners' Association, Inc., a Utah nonprofit corporation ("Association") and shall become effective when recorded with the Salt Lake County Recorder.

#### **RECITALS**

- A. The Association operates pursuant to the "Bylaws of Rowhaus Condominiums Homeowners' Association, Inc.", as recorded with the Salt Lake County Recorder on February 25, 2008, as Entry No. 10355738, in Book 9573, at Pages 7457-7466 ("Bylaws").
- B. Section 6.0 of the Bylaws provides that they may be amended upon the affirmative vote of a majority of the allocated interest of the Association.
- C. More than a majority of the allocated interest of the Association has approved the following amendments.
- D. All capitalized terms not otherwise defined herein shall have the meanings set forth in the Bylaws.

# **AMENDMENTS**

# Amendment One

Article II, Section 2.1 of the Bylaws is hereby amended to read as follows:

Annual Meetings. The annual meeting of the Members shall be held each year during the months of November or December on a day and at a time established by the Management Committee. The purpose of the annual meeting shall be electing Committee Members and transacting such other business as may come before the meeting. If the election of Committee Members cannot be held on the day designated herein for the annual meeting of the Members, or at any adjournment thereof, the Management Committee shall cause the election to be held either at a special meeting of the Members to be convened as soon thereafter as may be convenient or at the next annual meeting of the Members. The Management Committee may from time to time by resolution change the date and time for the annual meeting of the Members.

### **Amendment Two**

# Article III, Section 3.2 of the Bylaws is hereby amended to read as follows:

3.2 Number, Tenure, and Qualifications. The property, business, and affairs of the Association shall be governed and managed by a Management Committee composed of three (3) persons, each of whom small meet the qualifications in the Declaration. At each annual meeting, the Members shall elect for terms of two (2) years each the appropriate number of Committee Members to fill vacancies by expiring terms of Committee Members.

The foregoing amendments were duly approved by more than a majority of the allocated interest of the Association in accordance with Section 6.0 of the Bylaws.
