EASEMENT

John A. Marchbanks and Marjean Marchbanks, his wife, Grantors, do hereby convey and warrant to PacifiCorp, an Oregon corporation, dba Utah Power & Light Company, whose principal place of business is located at 1407 West North Temple, Salt Lake City, Utah, its successors in interest and assigns, Grantee, for the sum of Ten (\$10.00) Dollars and other valuable consideration, a perpetual easement and right of way for the erection, operation, maintenance, repair, alteration, enlargement, inspection, relocation and replacement of electric transmission and distribution lines, communications circuits, fiber optic cables and associated facilities, and no poles and no guy anchors, with the necessary guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said lines and circuits, on, over, under and across real property located in Utah County, Utah, described as follows:

A right of way 50 feet in width, being 25 feet on each side of the following described survey line:

Beginning on the west boundary line of the Grantor's land at a point 2378 feet westerly along the one quarter section line and 28 feet north, more or less, from the east one quarter corner of Section 4, T. 6 S., R. 2 E., S.L.M., thence N.89°06'E. 69 feet, more or less, to the east boundary line of said land and being in the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of said Section 4; containing 0.08 of an acre, more or less.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and


