# DEED OF TRUST MODIFICATION AGREEMENT (Utah County)

NOTICE IS HEREBY GIVEN that Grantor, Beneficiary, and the other parties, if any, that have entered into that certain Amended and Restated Credit Agreement dated November 18, 2022, ("Modification Agreement") whereby, among other modifications, the maturity date of the Note has been extended to November 1, 2023, as provided therein, and the maximum revolving principal amount of the loan available under the Note is being increased to \$50,000,000.00. The terms and conditions of the Modification Agreement are incorporated herein by this reference.

To secure the Loan as amended by the Sixth Amended and Restated Revolving Promissory Note of even date herewith, which amends and restates the Fifth Amended and Restated Promissory Note, dated November 17, 2021, in the maximum principal amount of \$35,000,000.00, which amended and restated that certain Fourth Amended and Restated Promissory Note, dated October 17, 2019, in the maximum principal amount of \$25,000,000.00, which amended and restated that certain Third Amended and Restated Promissory Note, dated November 1, 2017, in the maximum principal amount of \$20,000,000.00, which amended and restated that certain Second Amended and Restated Promissory Note, dated October 9, 2015, in the maximum principal amount of \$15,000,000.00, which amended and restated that certain Amended and Restated Promissory Note, dated November 1, 2014, in the maximum principal amount of \$10,000,000.00, which amended and restated that certain Promissory Note, dated November 12, 2013, in the maximum principal amount of \$8,000,000.00, Section 2.1(a) of the Deed of Trust is hereby amended and restated in its entirety as follows:

(a) Payment to Beneficiary of all sums at any time owing under the Sixth Amended and Restated Promissory Note (as amended from time to time, the "Note") dated as of November 18, 2022, in the principal amount of FIFTY MILLION AND NO/100THS DOLLARS (\$50,000,000.00) executed by ALPINE HOMES, LLC, a Utah limited liability company, HARBOUR HOMES, LLC, a Washington limited liability company, and RIVERSIDE HOMES, LLC, an Oregon limited liability company (each and collectively, joint and severally, "Borrower"), and payable to the order of Beneficiary. The interest rate, payment terms, or the balance due on such note and the indebtedness evidenced thereby may be indexed, adjusted, renewed, or renegotiated without affecting the priority of this Deed of Trust; and

The terms and conditions of the Deeds of Trust, as amended and supplemented by this Agreement, remain in full force and effect and are hereby affirmed and ratified.

This Agreement is not intended and shall not be construed to impair the validity, priority or enforceability of any Deed of Trust.
