the following described tract of land:

Beginning 1033.41 feet North and 1165.09 feet East of a square sandstone monument marking the Southwest corner of Section 10, Township 2 South, Range 1 East, Salt Lake Base and Meridian (This corner is described in some deeds as being 5.5 feet South and 34.79 feet West of monument in its present location); thence South 104.5 feet; thence West 104.5 feet; thence North 104.5 feet; thence East 104.5 feet, to the place of beginning; containing 0.25 acres.
