(Grantors) hereby convey and warrant to Brigham City Corporation, its successors and interests and assigns, (Grantees) for the sum of \$10.00, a perpetual easement hereinafter described to grade, construct, reconstruct, operate, repair, replace, and maintain public utility service lines and drainage systems, as may be authorized by Brigham City Corporation in, over, upon, across, and through those portions of Grantor(s) land lying in the tract of land located in Box Elder County, Utah, and described as follows to wit:

A public utility easement being ¹⁰~~15~~ feet wide from Station 0+00 to Station 4+35.50 and 6 feet wide from station 4+35.50 to Station 4+93.50 and 2.3 feet wide from Station 4+93.50 to Station 6+63.45 for utility purposes, the east line of which is the East line of Block 5, Plat "A", Brigham City Survey described as follows:

A part of Block 5, Plat "A" Brigham City Survey in Brigham City, Box Elder County, Utah:

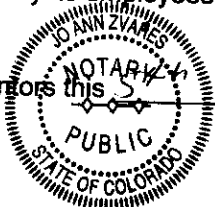

Together with all rights of ingress and egress necessary or convenient for all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions, which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
