The land of the grantors, Richard Chamberlain  $\frac{1}{2}$ , Edward Chamberlain  $\frac{1}{2}$ , located in Lot 8, Block 12, Flat 7th S.I.T. Survey.

the center line of which said gas pipe line shall extend through and across the above described land and premises on a line described as follows, to-wit:

Center line of gas main to be located as described on the attached blueprint by reference made a part hereof.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns, so long as such pipe line or lines, gates or gate boxes shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, remove, and replace the same.
