WHEREAS, the parties have previously entered into that certain Development Agreement for Aspen Meadows PUD, Morgan County, Utah dates January 9, 2008 and recorded as Entry No. 111103, Book 260, Page 183 by the Morgan County Recorder (the "Agreement") and affecting the properties described in Exhibit A; and

WHEREAS, section 2.9 of the Agreement contains certain provisions regarding moderate or affordable housing and a dispute has arisen between the parties with respect to the enforceability of those provisions in the Agreement (the "Dispute"); and

WHEREAS, without waiving or conceding their respective positions regarding the Dispute, the parties desire to amend the Agreement to resolve the Dispute; and

WHEREAS, based on certain anticipated pricing information provided by the Developer, it now appears that most, if not all, of the units in the Aspen Meadows PUD will be available to households making 80% of the average median income in Morgan County.

NOW, THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the County and Developer hereby agree as follows:

- 1. Section 2.9 of the Agreement is hereby deleted in its entirety.
- 2. Other than as specifically modified by this Agreement No. 1, all other provisions of the Agreement shall remain in full force and effect.
