ORDINANCE ESTABLISHING THE WEST WARREN PARK SERVICE AREA

WHEREAS, pursuant to the statutory requirements of 17A-2-401 Utah Code Annotated, residents of an area in West Weber County commonly known as West Warren have submitted petitions to the Board of County Commissioners of Weber County requesting that the Board of County Commissioners establish a park service area for the purpose of providing recreational facilities for the residents of the area, and

WHEREAS, pursuant to Section 17A-2-406 Utah Code Annotated, the Board of County Commissioners has previously adopted an initial resolution expressing its intent to establish a County service area for the provision of said services; and

WHEREAS, pursuant to the provisions of 17A-2-406(6), the Board of County Commissioners of Weber County held a public hearing on the matter on the 13th day of December, 1993, and no opposition was expressed to establishing the service area;

NOW THEREFORE, the Board of County Commissioners of Weber County ordains as follows:

SECTION ONE

Weber County Service Area No. 5, West Warren Park, is hereby established in accordance with Section 17A-2-401 Utah Code Annotated, 1953 as amended.

SECTION TWO

The boundaries of the service area are hereby established as follows:

Beginning at the North West corner of Section 2 Township 6 North, Range 3 West, Thence West 4 miles along the Township line to the North West corner of Section 6; then south 3.5 miles along the township line to the West quarter corner Section 19; thence southeasterly to the Southwest corner of Section 26; thence East 1.5 miles to the South quarter corner of Section 25, thence North 1.5 miles to the center of Section 24, thence East 0.5 miles to the East quarter corner of Section 24, thence North 1.0 miles to the East quarter corner of Section 13, thence West 0.5 miles to the center of Section 13, thence North 1.0 miles to the center of Section 12, thence West 1.5 miles to the West quarter corner of Section 11, thence North 1.5 miles to the point of beginning.

SECTION THREE

The service area is hereby established for the development and maintenance of a park and related facilities within the boundaries of the district.

SECTION FOUR

A property tax sufficient to pay for the development and maintenance of the park and services shall be levied upon all taxable property within the district. The property tax shall be levied by the Board of Trustees pursuant to State law.

SECTION FIVE

The Board of County Commissioners shall appoint a Board of Trustees to govern the service area pursuant to 17A-2-412 and 17A-1-301 Utah Code Annotated 1953 as amended.
