between EVERETT W. RANCK and MARY RANCK, husband and wife, first party,  
and SALT LAKE PIPE LINE COMPANY, a corporation, second party, WITNESSETH:

WHEREAS first party did by grant of right of way dated August  
20, 1952, and recorded August 28, 1952 in Book 41 of Official Records at  
Page 436 et seq, Records of Davis County, State of Utah, grant to second  
party certain rights, more particularly described in said grant, AND

WHEREAS, the parties hereto desire to change a portion of said  
grant.

NOW THEREFORE, it is mutually agreed that that portion of the  
description which reads as follows:

Said lines shall be laid within a strip of land Ten (10) feet  
in width, the Easterly boundary line of which is described as follows:  
Beginning at a point on a southerly boundary fence line of the  
lands of the grantor herein and a northerly boundary fence line of the  
lands of Salt Lake Union Stockyards, distant thereon westerly 72.9  
feet from the center line of the D. & R. G. W. Railroad right of way;  
thence N. 11° 52' E. 254.7 feet; thence N. 16° 54' E., 51 feet, to a point  
on an easterly fence line of the grantor herein and a westerly fence  
line of a county road, distant thereon southerly 363.4 feet from a  
fence corner; thence approximately N. 16° 54' E. to the center line of a  
four rod street.

shall be and the same is hereby amended to read as follows:

Said lines shall be laid within a strip of land ten (10) feet  
in width, the easterly boundary line of which is described as follows:  
Beginning at a point on a southerly boundary fence line of the  
lands of the Grantor herein and a northerly boundary fence line of the  
lands of the Salt Lake Union Stock Yards, distant thereon westerly  
70.7 feet from the center line of the Denver & Rio Grande Western  
Railroad right of way; thence North 12° 36' East 203.00 feet; thence  
approximately North 45° 04' East 28 feet, more or less, to an easterly  
fence line of the Grantor herein and a westerly fence line of a county  
road, distant thereon southerly 440 feet from the most northerly fence  
corner of the lands of the Grantor; thence continuing North 45° 04' East  
19 feet; thence northeasterly to the center line of said county road.

In all other respects said grant of right of way dated August  
20, 1952, shall remain in full force and effect.
