ROBERT M. AND CHERI A. WARDLEIGH OF WEST POINT CITY, STATE OF UTAH, HEREINAFTER REFERRED TO AS APPLICANT, AND WEST POINT CITY, A CITY IN THE STATE OF UTAH, HEREINAFTER REFERRED TO AS THE CITY, HEREBY MUTUALLY AGREE AS FOLLOWS:

PRELIMINARY: APPLICANT IS OWNER OF REAL PROPERTY SITUATED IN THE CITY, WHICH PROPERTY IS PARTICULARLY DESCRIBED AS FOLLOWS, TO WIT:

BEGINNING AT A POINT WEST ALONG SECTION LINE 262.2 FEET FROM THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION 5, TOWNSHIP 4 NORTH, RANGE 2 WEST: SALT LAKE MERIDIAN; THENCE WEST 110 FEET ALONG NORTH LINE OF SAID SECTION: THENCE SOUTH 194 FEET; THENCE EAST 110 FEET; THENCE NORTH 194 FEET TO POINT OF BEGINNING. SUBJECT TO STREET RIGHT OF WAY OVER THE NORTH 33 FEET.

IN THE EVENT A SPECIAL IMPROVEMENT DISTRICT IS ORGANIZED FOR THE PURPOSE OF INSTALLING THE SAID OFF-SITE IMPROVEMENTS, THE APPLICANT OR HIS/HER SUCCESSORS WILL PAY THE COST OF SUCH IMPROVEMENTS, THROUGH THE SAID IMPROVEMENT DISTRICT.
  - COMPLIANCE WITH CITY ORDINANCES AND SPECIFICATIONS.

IS AGREED THAT THE INSTALLATION OF SAID OFF-SITE IMPROVEMENTS SHALL BE DONE IN ACCORDANCE WITH ALL APPLICABLE CITY ORDINANCES, SPECIFICATIONS, STANDARDS, AND ANY ADMINISTRATIVE RULES OR REGULATIONS PERTINENT THERETO, AT THE TIME OF INSTALLATION. WORK SHALL BE SUBJECT TO THE INSPECTION OF THE CITY BUILDING OFFICIAL OR HIS/HER AGENT; AND ANY QUESTION AS TO CONFORMITY WITH CITY SPECIFICATIONS OR STANDARDS OR AS TO THE TECHNICAL SUFFICIENCY OF THE WORK SHALL BE DECIDED BY THE SAID BUILDING OFFICIAL, AND HIS/HER DECISION SHALL BE FINAL AND CONCLUSIVE.

- GRANT OF LIEN.
