EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that Marvel L. Moore, Verda E. Moore

of Duchesne County, Utah, Grantor(s), in consideration of the sum of one dollar and other good and valuable consideration to him paid by Duchesne City, hereinafter called the Grantee, the receipt of which is hereby acknowledged, does hereby grant and warrant to the said Grantee, its heirs, administrators, successors and assigns a temporary right and easement 100 ft. wide, 50 ft. on the left or westerly side, and 50 ft. on the right or easterly side of the following described centerline, to construct, erect, install and lay a culinary water pipeline with appurtenant structures; and a permanent right and easement 33 ft. wide, 16.5 ft. on the left or westerly side and 16.5 ft. on the right or easterly side of the following described centerline, to use, operate, maintain, inspect, repair, replace and remove said pipeline with appurtenant structures upon, over or across land described and shown below and owned by the Grantor(s) lying in Duchesne County, Utah, together with the right of ingress and egress thereto.

DESCRIPTION OF CENTERLINE:

Beginning at a point, 133.72 ft. west of the southeast corner of block 116, Duchesne Townsite Survey, said point being engineer's station 11 + 61.74; and running th. N28°08'W 362.25 ft. to engineer's station 15 + 23.99, being the north line of said block 116.

PROVIDED, HOWEVER, that the exercise by the Grantee of the rights hereby granted shall be subject to, and in accord with, the following conditions:  
Top soil replaced and debris removed. Replace, repair or pay for any damage.
