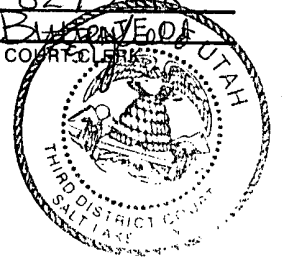

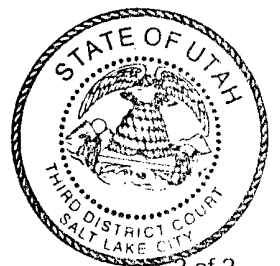
1. For property damages in the amount of **\$2,845.16**
