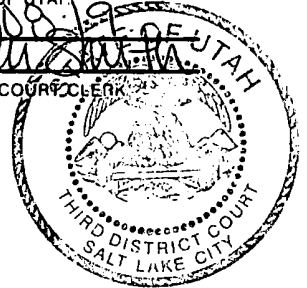

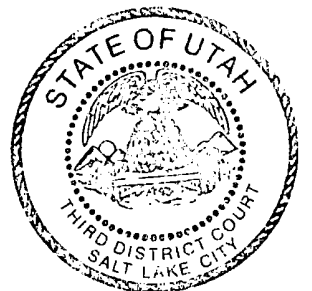
1. For Judgment in the principal sum of \$13,895.70.
