1 AMENDMENT TO DECLARATION OF RESTRICTIVE AND PROTECTIVE
 2 COVENANTS AND CONDITIONS OF MARRCREST PLANNED-UNIT
 3 DEVELOPMENT

4 M. WARNER MURPHY and CORALEE A. MURPHY, husband and wife,
 5 the owners of record of the real property hereinafter described, hereby amend
 6 the original declaration of restrictive and protective covenants and conditions
 7 of Marrcrest Planned-Unit Development recorded March 8, 1968, in Book
 8 1105 at Pages 72-85 in the office of the Utah County Recorder, Provo, Utah
 9 County, State of Utah, to include the following described real property, to-wit:

 13 Township 6 South, Range 2 East, Salt Lake Base and Meridian,
 14 said point of beginning being the Southwest corner of Lot 17,
 15 Section "A", Marrcrest Planned-Unit Development, Provo,
 16 Utah, according to the official plat thereof on file in the office
 17 of the Recorder, Utah County, Utah; thence North along the
 18 West boundary of said Marrcrest Section "A" 130.17 feet; thence
 19 South 85° 26' East along said Marrcrest Section "A", 4.83
 20 feet; thence North 1° 34' East along said Marrcrest Section
 21 "A", 133.55 feet; thence North 89° 00' West 75.50 feet; thence
 22 South 17° 22' West 75.27 feet; thence South 55° 37' West 87.91
 23 feet; thence North 85° 26' West 1.54 feet; thence along the arc
 24 of a 149.00 foot radius curve to the right 84.52 feet (the chord
 25 of said curve bears North 69° 11' West 83.39 feet); thence
 26 along the arc of a 90.00 foot radius curve to the right 19.06 feet
 27 (the chord of said curve bears North 46° 52' West 19.02 feet);
 28 thence South 49° 12' West 30.00 feet; thence South 62° 21' West
 29 148.93 feet; thence South 5° 00' West along the Easterly bound-
 30 ary of the Denver and Rio Grande Railroad right-of-way 98.64
 31 feet; thence North 89° 51' 10" East 418.64 feet to the point of
 32 beginning. Area - 1.67 acres.

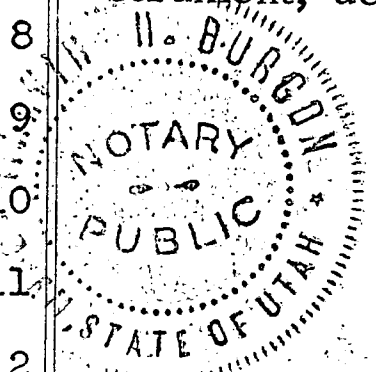
