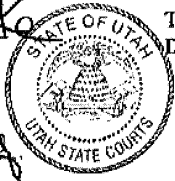

1. On 11/1/2010 judgment was entered in favor of Plaintiff in the amount of \$3,161.60 at 2.41 % plus accruing post judgment costs expended in the collection of the judgment.
