SECOND AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, EASEMENTS AND RESTRICTIONS FOR INDEPENDENCE AT THE POINT

This Second Amendment to the Declaration of Covenants, Conditions, Easements and Restrictions for Independence at the Point (the "Second Amendment") is executed and adopted by 4 Independence, LLC (the "Declarant").

RECITALS

- A. The Declaration of Covenants, Conditions, Easements and Restrictions for Independence at the Point was recorded on October 17, 2012 as Entry No. 11493945 in the office of the Salt Lake County Recorder (hereinafter the "Declaration").
- B. The Amendment to Declaration of Covenants, Conditions, Easements and Restrictions for Independence at the Point was recorded on June 15, 2016 as Entry No. 12300512 in the office of the Salt Lake County Recorder.
- C. This Second Amendment affects the real property located in Salt Lake County, described with particularity on Exhibit A, which exhibit is attached hereto and incorporated herein by reference.
- D. The Association desires to amend the Declaration as set forth in this Second Amendment to incorporate restrictions on the leasing of Dwelling Units within the project.
- E. Unless otherwise set forth herein, the capitalized terms shall have their same meanings and definitions as stated in the Declaration.
- F. Pursuant to Article XVIII, Section 18.3 of the Declaration, the undersigned hereby certifies that this Second Amendment was approved by the Declarant pursuant to its unilateral amendment power.
- NOW, THEREFORE, in consideration of the foregoing Recitals, the Declarant hereby executes this Second Amendment, which shall be effective as of its recording date with the Salt Lake County Recorder's office.

- (1) <u>Amendment No. 1</u>. Article IV, Section 4.2.26 of the Declaration shall be deleted in its entirety and shall be replaced as follows:
- Leases. The leasing of Dwelling Units is permitted. The Board may adopt 4.2.26 Rules to regulate the leasing of the Dwelling Units within the Project which may include, but are not limited to: requiring a copy of each lease to be provided to the Board, reporting of name and contact information for all adult tenants, reporting of vehicle information of the tenants, and any other information deemed necessary by the Board. Unless otherwise modified by Association Rule, the following leasing restrictions shall apply: (a) no Owner shall be permitted to lease his/her Dwelling Unit for transient, hotel, VRBO, Airbnb, or similar purposes; (b) all leases shall be for an initial term of no less than six (6) months; (c) daily or weekly rentals are prohibited: (d) no Owner may lease individual rooms to separate persons or less than his/her entire Dwelling Unit, unless the Owner is also living in such Dwelling Unit; (e) no portion of the Dwelling Unit or Lot may be rented out for storage; and (f) all leases shall provide that the tenant is subject to and shall abide by the Declaration and Rules, and the tenant's failure to do so shall constitute a breach of the lease agreement. Within 10 days after delivery of written notice of the creation of a nuisance or violation of the Declaration or other governing documents by a tenant, the Owner shall proceed promptly to either abate or terminate the nuisance, or cure the default, and notify the Board in writing of his or her intentions. If the Owner fails to act accordingly, the Board may initiate eviction proceedings on behalf of the Owner, and through this Declaration the Owner hereby assigns the Association the authority to do so. All costs incurred by the Association to enforce the terms of the Governing Documents against a tenant shall be assessed to the Owner as a specific assessment against its lot. The leasing restrictions set forth in this Section shall not apply to the Declarant or a Declarant affiliated entity.
- **Conflicts**. All remaining provisions of the Declaration and any prior amendments not specifically amended in this Second Amendment shall remain in full force and effect. In the case of any conflict between the provisions of this document and the provisions of the Declaration or any prior amendments, the provisions of this document shall in all respects govern and control.
- (3) <u>Incorporation and Supplementation of Declaration</u>. This document is supplemental to the Declaration, which by reference is made a part hereof, and all the terms, definitions, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this document and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
