This Amendment to Declaration of Covenants, Conditions, Restrictions and ByLaws for Knollwood Condominium Phases I, II, III, IV, and V is made and executed this 1<sup>st</sup> day of July, 1993, by the undersigned for themselves, their successors, guarantees and assigns, pursuant to mutual agreement and to the provisions of the Utah Condominium Ownership Act.

WHEREAS, an Order of the Second Judicial District Court of Weber County, State of Utah, was executed by the Honorable Ronald O. Hyde, on March 22, 1991, and recorded as Entry No. 1134645, in Book 1596, page 515, in the Office of the Weber County Recorder, State of Utah, which eliminated Units 94, 96, 97, 98, and 99 of Knollwood Condominium, Phase V, subject to a reversion in the event that the property upon which such Units had been Platted was not constructed and being used as a recreational vehicle parking facility by October 1, 1991, or in the event it is constructed and in use by said date but thereafter is abandoned or diverted to another use; and

WHEREAS, a Quit Claim Deed was executed on March 18, 1991, by Evans Grain & Elevator Company, a Utah corporation, granting the property platted as Units 94, 96, 97, 98, and 99 of Knollwood Condominium, Phase V, to the Association of Unit Owners Knollwood Condominium, with the reversion described in the prior paragraph, recorded as Entry No. 1135251, in Book 1596, page 1758, in the Office of the Weber County Recorder, State of Utah; and

WHEREAS, said recreational vehicle parking facility was never constructed; and

WHEREAS, all of the above are binding on all of the properties referred to therein; and

WHEREAS, pursuant to paragraph 27 of the Declaration, the undersigned owners of the undivided interest in the common areas and facilities of all Phases of Knollwood Condominium agree to an Amendment to the Declaration, withdrawing Units 86, 87, 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 99, 100, 101, 102, 103, 104, 105, 106, 107, and 108, Phase V, from the Declaration.

THEREFORE, the undersigned hereby declare as follows:

1. The undersigned are owners of the undivided interest in the common areas and facilities of Knollwood Condominium, Phases I, II, III, IV, and V.

2. The Declaration is hereby amended, withdrawing Units 86, 87, 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 99, 100, 101, 102, 103, 104, 105, 106, 107, and 108, Phase V, therefrom.

3. The security and integrity of present mortgages of record on Knollwood Condominium, Phases I, II, III, IV, and V shall not be impaired by this Amendment.

4. This Amendment is binding on all Unit owners of Knollwood Condominium, Phases I, II, III, IV, and V, their heirs,

6. This Amendment may be executed in counterparts, each of which shall constitute an original.
