THEREFORE, the undersigned hereby declare as follows:

- The undersigned are owners of the undivided interest in the common areas and facilities of Knollwood Condominium, Phases I, II, III, IV, and V.
- The Declaration is hereby amended, withdrawing Units 86,
 87, 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 99, 100, 101, 102,
 103, 104, 105, 106, 107, and 108, Phase V, therefrom.
- 3. The security and integrity of present mortgages of record on Knollwood Condominium, Phases I, II, III, IV, and V shall not be impaired by this Amendment.
- 4. This Amendment is binding on all Unit owners of Knollwood Condominium, Phases I, II, III, IV, and V, their heirs,
