RECITALS

- A. Declarant previously recorded that certain Declaration of Protective Covenants, Conditions and Restrictions for South Hills Pod 4, recorded with the Salt Lake County Recorder on March 13, 2018 as Entry No. 12732616, in Book 10654, at Pages 9448-9484 (the "*Declaration*"). The Declaration subjects the Project commonly known as "South Hills Pod 4" to certain covenants, conditions and restrictions. Capitalized terms not otherwise defined in this Certificate of Amendment shall have the meaning ascribed to such terms in the Declaration.
- B. Section 11.4 of the Declaration grants Declarant the right to expand the Project at any time and from time to time by adding to the Project additional land or a portion or portions thereof, by recording a Certificate of Amendment containing the information required under Section 11.4 of the Declaration. Furthermore, Section 11.2 of the Declaration grants Declarant the right to unilaterally amend the Declaration for certain purposes.
- C. Declarant is the owner of all of that certain real property located in Salt Lake County, Utah, more particularly described on Exhibit A attached hereto ("South Hills Pod 4 Phase 2"). Pursuant to this Certificate of Amendment, Declarant is annexing South Hills Pod 4 Phase 2 into the Project, such that the provisions of the Declaration shall run with the land and be binding upon and inure to the benefit of all persons who hereafter become the Owner of any Lot, parcel, unit and/or other interest in South Hills Pod 4 Phase 2. Accordingly, this Certificate of Amendment supplements the Declaration as contemplated in Section 11.4 of the Declaration.

Furthermore, Owners of Lots, parcels or units within South Hills Pod 4 Phase 2 shall be Members of the Association.
- 2. <u>Incorporation; Amendment.</u> Declarant hereby incorporates by reference the covenants, conditions and restrictions in the Declaration, as if repeated and fully set forth herein. Furthermore, Declarant hereby amends the Declaration to the extent necessary to reflect the expansion of the Project to include South Hills Pod 4 Phase 2, and Section 11.4 is also amended by referencing South Hills Pod 4 as the Project that may be expanded by Declarant pursuant to the rights contained therein
- 3. <u>Severability</u>. Any determination by any court of competent jurisdiction that any provision of this Certificate of Amendment is invalid or unenforceable shall not affect the validity or enforceability of any of the other provisions hereof.
