

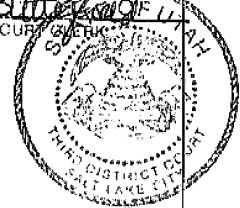

HEREBY FINDS, ORDERS, ADJUDGES AND DECREES THAT:

- On 3/14/2011 judgment was entered in favor of Plaintiff in the amount of \$1,660.63 at 2.30 %, plus accruing post judgment costs expended in the collection of the judgment.

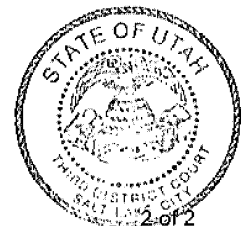


2. Since Judgment entered the following post judgment costs and interest have accrued:
