his wife, Grantor s. of Davis County, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and no guy anchors and 5 ~~crossarm~~ poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor s. in Davis County, Utah, along a line described as follows:

Beginning at existing pole on grantor's land at a point 870 feet north and 1035 feet east, more or less, from the southwest corner of Section 17, T.4 N., R.1 W., S.L.B. & M., thence running S.47°06'E. 169 feet, thence S.48°26'E. 226 feet, thence S.46°28'E. 187 feet, thence S.44°11'E. 190 feet, thence S.42°28'E. 212 feet, thence S.39°47'E. 189 feet to north fence of County Road on south boundary line of said land and being in the S 1/2 of the SW 1/4 of said Section 17.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.

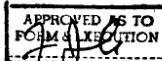
