DECLARATION OF EXPANSION  
 EL PUEBLO AT LA ESTANCIA

WHEREAS, the undersigned (hereafter "Developer") is the owner of certain real property located in Kanab, Kane County, State of Utah, identified as EL PUEBLO AT LA ESTANCIA, such property being more particularly described in Exhibit "A" attached hereto and made a part hereof and being referred to herein as the "Property."

WHEREAS, Developer has caused such Property to be subdivided and platted, to be recorded as Phase 2 of the El Pueblo at La Estancia Subdivision.

WHEREAS, Developer desires to and shall cause such Property to be conveyed subject to those protective covenants, conditions and restrictions as set forth in the declaration of Covenants, Conditions and Restrictions for El Pueblo at La Estancia Subdivision, Phase 1, dated December 13, 2005 and recorded in the official records of the Kane County Recorder on January 3, 2006, as Entry No. 127399, Book 0-294, Pages 706 through 724 (hereinafter "Covenants").

NOW, THEREFORE, Developer hereby declares that all of the Property shall be held, sold and conveyed subject to the Covenants, all of which are for the purpose of enhancing and protecting the value, desirability and attractiveness of the Property. The Covenants shall run to, with and from the Property, shall be binding on all parties having or acquiring any right, title or interest in the Property, and shall inure to the benefit of each such party. The lot owners of any of the Property shall be members of the El Pueblo at La Estancia Homeowners Association and shall enjoy the same rights and be under the same duties as any other member as set forth in the Covenants.

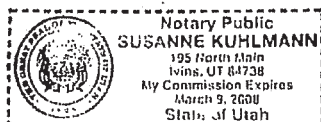
