Ronda stated this is a conditional use permit request for the purpose of boarding, keeping, breeding, buying, grooming, holding for adoption, letting for hire, training for profit, or selling for K&C Duncan's Black & Tan's Kennel. She stated the Planning Commission recommends approval based on the following findings and conditions:

### Findings:

- 1. That the request conforms to the requirements of the Morgan County Code.
- 2. That with the proposed conditions, potential detrimental impact to the public will be mitigated, particularly with respect to the adjacent water ways.
- 3. That Morgan County Code has specific codes to protect the public health, safety and welfare. Additional standards as may be established by the Planning Commission or County Council as they may deem necessary for the protection of the health, safety, convenience and general welfare of the present and future inhabitants of the County and the environment.
- 4. That the kennel is located in a riparian area.
- 5. That the applicant has limited himself to a maximum of 20 dogs, per his proposal.

### Conditions:

- 1. That the applicant works with the Weber-Morgan Health Department and the State of Utah Division of Water to ensure that the adjacent water ways remain free and clear of pollutants.
- 2. That the applicant applies for and maintains a business license for the kennel operations in Morgan County.
- 3. That the applicant schedules a site inspection with the Weber-Morgan Health Department and receives approval prior to the issuance of a business license.
- 4. That the applicant applies for and maintains the appropriate licenses for the dogs associated with the kennel.
- That the kennel operation and associated business adheres to all other County, State and Federal requirements.
- 6. That all dog feces be bagged and removed from the location.

Ronda noted the Animal Control Officer has visited this location and finds favorable conditions for this business and the animals are being well cared for.

Member Mecham moved to approve the K&C Duncan's Black and Tan Conditional Use Permit with the findings and conditions of the Planning Commission and Staff. Seconded by Member Ballantyne. The vote was unanimous. The motion passed.

Dave Manning – Discussion/Decision – Verification of street names on the following Morgan County Streets: Whisper Ridge Pkwy/Robinson Ln, Wasatch Dr/Wasatch Ave, Sierra Dr/Sierra Ave, Cottonwood Rd/Cottonwood Canyon Rd

Dave stated that during the processes of creating address points for Morgan County and updating road centerlines based on this new data, there were a number of discrepancies discovered with regards to the names of some streets within the County. He noted that the current County Code needs to be updated as it relates to addressing and street naming. He stated his objective is seeking to verify and adopt street names for four streets that are most critical street name discrepancies in the County.

It was noted that Whisper Ridge Parkway/Robinson Lane will all be Robinson Lane, Wasatch Drive/Wasatch Ave will all be Wasatch Drive, Sierra Drive/Sierra Avenue will all be Sierra Drive and Cottonwood Road/Cottonwood Canyon Road will all be Cottonwood Canyon Road.

Dave stated that the affected citizens will have a door hanger placed at their residence notifying them of the change with a 30 day notification with a final notification being sent when the change takes effect. He noted the necessary street signs will be changed.

Member Kilmer moved to approve the name designations to retain Robinson Lane and discard Whisper Ridge Parkway, retain Wasatch Drive and discard Wasatch Avenue, retain Sierra Drive and discard Sierra Avenue and retain Cottonwood Canyon Road and discard Cottonwood Road with the following findings:

- 1. That the street name changes are necessary to clarify duplicity of names and provide continuity of street names along these streets.
- 2. That the street name changes will enhance rapid location of properties by law enforcement, fire, rescue and emergency medical service personnel in Morgan County.
- 3. That the street name changes are in favor of the County's health, safety and welfare.

Seconded by Member Ballantyne. The vote was unanimous. The motion passed.

### Mike Mellott - Discussion/Decision - Refund on property taxes; charged as non-primary residence

Mike Mellott stated that his 2012 property taxes were high because his residence was classified as a non-primary residence. He noted the taxes he paid were \$6,075.41 and with his home as a primary residence it should have only been \$3,341.47; he is requesting a refund of \$2,733.94.

It was noted that the Assessor and Treasurer are not in favor of granting this refund because all tax dollars for 2012 have been apportioned and the books are closed.

Member Kilmer stated he does not have a problem with refunding the County portion of his tax.

Chair Kelley stated if protocol is followed the same as a motor vehicle refund then he would need to receive a refund from each of the other taxing entities before the County would refund their portion.

Member Wilde moved to deny the refund as it would be setting a precedence for the other entities. Seconded by Member Mecham. Members Nelson, Kilmer and Ballantyne voted against. All other members voted for. The motion passed.

### Brent Anderson - Discussion - Levy facts and long term solutions

Brent Anderson stated he attended a meeting regarding the Tax Levy for the Morgan County School District and is not happy about the additional taxes. He stated if this levy is approved it will never go away and taxes are going to continue to go up. He asked the Council to look at ways to bring businesses into the County.

It was noted that the County is working on encouraging businesses to locate in Morgan.

### Logan Wilde - Discussion/Decision - Bag of Woad program

Member Wilde stated that the Morgan Conservation District is requesting a donation for a dumpster and tipping fees which are approximately \$300 with an additional \$300 to put back in the Morgan County Bag of Woad program for the Conservation District. He noted this has been a successful program in the past and appreciates the continued support of the County.

It was noted that the donation of the dumpster and tipping fees has been paid out of the garbage account in the past.

Member Wilde moved to approve for the Conservation District to use the property by the road shed for a dumpster for the bag of woad and approve the donation of the dumping and tipping fees with an additional \$300 for the Conservation District to put back in their fund with the donation coming from the garbage fund. Seconded by Member Mecham. The vote was unanimous. The motion passed.

### Logan Wilde - Discussion/Decision - Sage Grouse resolution

Member Wilde stated the state has asked each County to come up with a resolution to support the state to help mitigate the problems associated with the sage grouse throughout the state. He stated there is still wording that needs to be worked out but the State had initially requested that it be approved by each County by May  $6^{th}$ .

It was noted this resolution shows support to the other counties most impacted by the sage grouse.

Chair Kelley stated that if approved she would have Jann review the final copy before signing it.

Member Wilde moved to adopt Resolution CR-13-02 dealing with the Sage Grouse. Seconded by Member Kilmer. The vote was unanimous. The motion passed.
