ROY, UTAH 84067), its successors, assigns, lessees, licensees and agents, a perpetual easement to construct, reconstruct, operate, maintain and repair Utility lines as Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to wit:
