ELAINE FECHSER DAVIS, the affiant herein, being duly sworn, states and represents as follows:

1. On August 11, 1998, Dee Milton Davis, as Grantor, and Dee Milton Davis and Elaine Fechser Davis, as Trustees, established the DEE MILTON DAVIS FAMILY TRUST, dated August 11, 1998, as amended ("Trust").
2. Pursuant to the Trust, upon the death of Dee Milton Davis, his spouse, Elaine Fechser Davis, and their daughter, Gayle Faye Davis Warren, were nominated and appointed as successor co-trustees of the Trust.
3. On March 5, 2017, Dee Milton Davis passed away. Attached as Exhibit "A" and incorporated herein is a true and correct copy of his death certificate.
4. Dee Milton Davis, who is the individual named in the attached death certificate, is one and the same as Dee Milton Davis, who was the initial co-Trustee of the Trust.
5. Based on the death of Dee Milton Davis and by virtue of the terms and provisions of the Trust, the trusteeship thereby passed to Elaine Fechser Davis and Gayle Faye Davis

Warren, as successor co-trustees of the Trust.

6. The undersigned, hereby accept the office of successor co-trustees of the Trust and agree to perform the duties of trustee in their capacity as set forth in the Trust Agreement.

7. The Trust owns an interest in the following described real properties located at **1379 Major Street, Salt Lake City, UT and 1383 Major Street, Salt Lake City, UT, both real properties located in Salt Lake County, State of Utah**, more particularly described as follows:

10. As successor trustee, the undersigned has all of the powers of trustee as set forth in the Trust Agreement, including but not limited to, the power to own, sell, lease, and manage

the Property.






