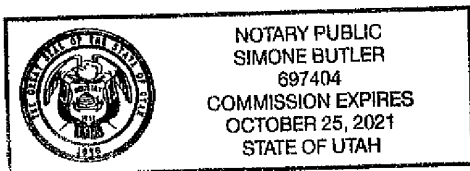

LEGAL DESCRIPTION AND TAX ID NUMBER OF
