Grantor, of Salt Lake City, Salt Lake County, State of Utah, hereby conveys and warrants to


**Eric C. Morgan, as Trustee of The Eric C. Morgan Revocable Trust dated the 30th day of June, 2009,**

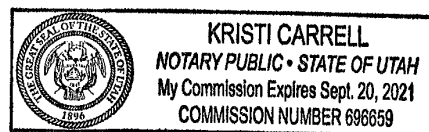
