

## LEGAL DESCRIPTION

### PARCEL 1:

Beginning at a point on the South right of way line and no access line of Interstate Highway 15, said point being North 89 deg. 51'30" West 258.81 feet along the North line of Section 23, and South 594.88 feet from the North quarter corner of Section 23, Township 1 North, Range 1 West, Salt Lake Base and Meridian, and running thence South 01 deg. 33'00" West 25.70 feet; thence South 01 deg. 36'00" West 245.87 feet to a point 10.00 feet perpendicularly Northwesterly from the center line of the Oregon Short Line Railroad Company lead tract No. "A" 438; thence South 42 deg. 35'00" West 108.01 feet, parallel to and 10.00 feet perpendicularly Northwesterly from the center of said tract, to a point on a 368.76 foot non-tangent curve to the right, (radius bears North 29 deg. 03'38" West); thence along the arc of said curve 157.43 feet; thence South 85 deg. 24'00" West 530.11 feet to a point on the Easterly right of way line of Interstate Highway 15, said point being on a 478.01 foot radius non tangent curve to the right, (radius bears South 85 deg. 45'18" East); thence along the arc of said curve 722.11 feet; thence South 89 deg. 12'00" East 275.24 feet along the South right of way line of said Interstate Highway 15 to the point of beginning.
