This DEED, ASSIGNMENT AND BILL OF SALE is made and entered into as of the 23rd day of June , 1986 by and between Kaiser Coal Corporation and Kaiser Coal Corporation of Sunnyside, both Delaware corporations, (collectively, "Kaiser") as parties of the first part, and Kaiser Fuel Corporation, a Delaware corporation, having its principal place of business at 102 South Tejon, Suite 800, Colorado Springs, Colorado 80903 ("Grantee"), as party of the second part.

## WITNESSETH

WHEREAS, Kaiser is the owner of various interests in real property and personal property located in Carbon County and Emery County, Utah as described in the attached Exhibit "A"; and

WHEREAS, Kaiser desires to transfer, convey, assign, grant and sell to the Grantee, without warranty, the estate in, and only in, the gob, coal tailings and waste piles now or hereinafter located on or in the lands and leases described in Exhibit "A" whether such estate is classified as real property or personal property ("Property") under Utah law; and

WHEREAS, Kaiser also desires to grant to Grantee the right to enter onto the premises described at Exhibit "A" for the purpose of extracting and/or removing and using the gob, coal tailings and waste piles now or hereinafter located on or in those lands and/or the right to transport, store or stockpile these materials for use on the premises.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) cash in hand paid to Kaiser and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, Kaiser does hereby grant, sell, assign, set-over, transfer, quit-claim and convey to Grantee, its successors and assigns, without warranty, the following:

## REAL PROPERTY

The real property interest in, and only in, gob, coal tailings and waste piles now or hereinafter located on or in the lands described in Exhibit "A", together with all easements and rights-of-way necessary to develop, extract, mine or remove the same from these lands or to transport, store and/or stockpile these materials for use on the premises; subject, however, to all existing liens, encumbrances, easements, rights-of-way, licenses, grazing and agricultural leases, royalties and all other adverse interests whatsoever, whether recorded or not, as of even date herewith, except as otherwise provided.

## PERSONAL PROPERTY

The personal property interest in, and only in, gob, coal tailings and waste piles now or hereinafter located on or in the lands described in Exhibit "A"; subject, however, to all existing security agreements, financing statements and all other adverse interests, whether recorded or not, as of even date herewith except as otherwise provided.

Kaiser makes no warranties or representations, either expressed or implied, as to the title to the Property herein sold, transferred and assigned.

The Property transferred unto the Grantee pursuant to this Deed, Assignment and Bill of Sale is being transferred in an "as is", "where is" condition and, other than expressly provided herein, is being transferred without any representations, obligations or warranties whatsoever, whether express or implied, including without limitation any warranty, obligation or liability of Kaiser with respect to fitness, merchantability or consequential damages, whether or not occasioned by the fault or negligence of Kaiser.

Grantee assumes and agrees to discharge all obligations, if any, resulting from the development, extraction, removal, transportation, storage or use of gob, coal tailings or waste piles from or on the Property described in Exhibit "A".

Grantee recognizes that certain rehabilitation and reclamation work may be required resulting from the development, extraction, removal, transportation, storage or use of gob, coal tailings and waste piles in connection with the coal mines and coal preparation plant located upon the Property, including, without limitation, the mines at Sunnyside and Geneva and the Wellington Preparation Plant, and Grantee assumes and agrees to discharge all obligations imposed by the United States, the State of Utah, or any political subdivision thereof, in effect or hereafter enacted regulating or relating to the rehabilitation or reclamation of the Property, or any portion thereof.
