UTAH POWER & LIGHT COMPANY, a Maine corporation, Grantor, hereby grants to SALT LAKE CITY, a municipal corporation of the State of Utah, Grantee, and its assigns for One Dollar (\$1.00) and other valuable consideration, an easement and right of way for the construction, maintenance, operation, repair and replacement of a 10 by 15 foot concrete meter box extending approximately 18 inches above ground surface of west bank of Jordan River, including 16 inch cast iron water pipe connections and pipe trestle abutment, the center of said box being 38.89 feet South and 920.5 feet East from the Northwest corner of Section 2, T. 1 S., R. 1 W., S.L.B. & M., together with the right of ingress to and egress from the said meter box, connections and abutment over the adjoining real property of the Grantor for the purposes herein set forth, RESERVING TO THE GRANTOR, however, the right at any time to remove and relocate the said meter box, connections and abutment at its own expense to a place satisfactory to the Grantor.


